DESIGNATED PAYEE

This instrument, and your acceptance thereof, is not a transfer of the Letter of Credit, does not give to the Designated Payee any interest therein and does not affect our or your right to agree to amendments thereto, the cancellation, or any substitution therefore.

We warrant to you that we have not, and will not, by negotiation of drafts or otherwise, assigned the right to receive the whole or any part of such proceeds, or give any other authorization or direction to make any payments thereof to any third party. Please advise the Designated Payee of your acceptance of this instrument and, in consideration thereof, we agree that this instrument is irrevocable. In the event of any refusal by you to make payment upon any draft drawn under the credit, the Designated Payee will not have any rights as against you and shall be bound by your determination.

We agree to indemnify you and hold you harmless for any claim, loss, liability of expense (inclusive, without limitation attorney's fees and expenses) to which you may become subject in connection with this instrument.

We transmit to you herewith the Credit (including all amendments, if any) and request you to note thereon the foregoing authorization and direction.

We enclose our check or debit our account above to cover your expenses.
